Consent Declaration for the Use of Photographic Images pursuant to Art. 9(2)(a) GDPR

This consent declaration is made in compliance with the German Federal Data Protection Act (BDSG), the EU General Data Protection Regulation (GDPR) applicable since 25 May 2018, and all other relevant data protection legislation. The statutory provisions in force from time to time shall apply to this agreement in their respective current version.

This consent declaration concerns the collection, processing and use of personal data within the meaning of the BDSG and the GDPR by the controller, taking the consent into account. 4. Recipients of Your Data

Your (special category) personal data will not be transmitted to third parties.

5. Your Rights

You have the right to obtain information about the personal data concerning you (Art. 15 GDPR). You may also request the rectification of inaccurate data (Art. 16 GDPR). In addition, under certain circumstances, you have the right to erasure of data (Art. 17 GDPR), the right to restriction of processing (Art. 18 GDPR) and the right to data portability (Art. 20 GDPR). You have the right to withdraw your consent to future processing (Art. 7(3) GDPR). Furthermore, where applicable, you also have a right to object pursuant to Art. 21 GDPR in the event of processing based on legitimate interests. You also have the right to lodge a complaint with the competent data protection supervisory authority if you believe that the processing of your personal data is unlawful.
